1.0 Perform an underwater inspection of the piling for the following structures:

- 1.1 Barge Docks 1-6, Sheet Pile Bulkhead (1,420 lineal feet)
- 1.2 Barge Dock Mooring/Breasting Dolphins (10 each, 3-pile and 6 each, 4-pile)
- 1.3 Barge Dock Bumper Dolphin Pipe Piles (18 each)

2.0 Inspection Program

- 2.1 <u>Level I Inspection</u> Perform a visual and tactile examination of the piling from the mud line to the high waterline for all of the piles supporting all the structures listed in Item 1.2 above
- 2.2 <u>Modified Level II Inspection</u> Perform a Modified Level II Inspection on 10% of the sheet piling and 50% of the pipe piles inspected per Item 2.1 above.

A Modified Level II inspection will consist of the removal of marine growth from the pile surface at one elevation to allow for a closer examination of the steel or concrete surfaces. This elevation may be selected by the Engineer, by the Diver or be a random selection.

For the sheet piling, clean a 12-inch high band. For round piles remove growth from at least 3/4 of the perimeter.

2.3 <u>Level III Inspection</u> - Perform a Level III Inspection on 50% of the piles inspected per Item 2.2 above. One (1) UT shot per pile.

For Level III, obtain ultrasonic thickness measurements and pit gauge readings.

3.0 Deliverables

Following the inspection, provide a written Inspection Report of Findings. The report will include the following:

- 3.1 A report summary of underwater findings of the inspections, with descriptions of damage, defects, and anomalies.
- 3.2 Photographs of the various components inspected, including photographs of damage, defects, and anomalies
- 3.3 Results of ultrasonic thickness testing measurements and pit gauge readings.
- 3.4 Field inspection forms.

3.5 Daily logs of work conducted.

AGREEMENT BETWEEN OWNER AND CONTRACTOR

THIS AGREEMENT is dated as of the _____ day of ______, in the year 2018, by and between the CALHOUN PORT AUTHORITY OF CALHOUN COUNTY, TEXAS (hereinafter called OWNER), and ______ (hereinafter called CONTRACTOR).

OWNER and CONTRACTOR, in consideration of the mutual covenants hereinafter set forth, agree as follows:

Article 1 - WORK:

CONTRACTOR shall complete all Work as specified or indicated in the Contract Documents. The Work is generally described as follows:

Article 2 - CONTRACT TIME:

The **CONTRACTOR** shall commence the work within **Fifteen (15) Calendar Days** of the date of the issuance of a Purchase Order and shall be pursued with all reasonable diligence (excepting acts of God, civil disturbances, or other situations agreed to by the **OWNER** as being beyond the responsibility of the **CONTRACTOR**) and be deemed by the **OWNER** as Substantially Complete within **Thirty (30) Calendar Days** of the date of the Purchase Order or as directed and ordered by the **OWNER**.

Article 3 - CONTRACT PRICE:

OWNER shall pay **CONTRACTOR** for completion of the Work in accordance with the Contract Documents in current funds as follows:

Article 4 - PAYMENT PROCEDURES:

CONTRACTOR shall submit invoice for payment in the amount of 100% upon completion of the Scope of Work, Including all Reports and Test Results.

In order to induce **OWNER** to enter into this Agreement, **CONTRACTOR** makes the following representations:

- **5.1 CONTRACTOR** has familiarized itself with the nature and extent of the Contract Documents, Work, site, locality, and all local conditions and Laws and Regulations that in any manner may affect cost, progress, performance or furnishing of the Work.
- **5.2 CONTRACTOR** has given **OWNER** written notice of all conflicts, errors or discrepancies that he has discovered in the Contract Documents and the written resolution thereof by **OWNER** is acceptable to **CONTRACTOR**.

Article 7 – INDEMNIFICATION:

TO THE FULLEST EXTENT PERMITTED BY LAWS AND REGULATIONS, CONTRACTOR SHALL INDEMNIFY AND HOLD HARMLESS OWNER, ENGINEER, AND THE OFFICERS, DIRECTORS, PARTNERS, EMPLOYEES, AGENTS, CONSULTANTS AND SUBCONTRACTORS OF EACH AND ANY OF THEM FROM AND AGAINST ALL CLAIMS, COSTS, LOSSES, AND DAMAGES (INCLUDING BUT NOT LIMITED TO ALL FEES AND CHARGES OF ENGINEERS, ARCHITECTS, ATTORNEYS, AND OTHER PROFESSIONALS AND ALL COURT OR ARBITRATION OR OTHER DISPUTE RESOLUTION COSTS) ARISING OUT OF OR RELATING TO THE PERFORMANCE OF THE WORK, OR THE FAILURE OF CONTRACTOR TO PERFORM ITS OBLIGATIONS OR UNDERTAKINGS AS STATED IN THE CONTRACT DOCUMENTS, OR THE INACCURACY OF ANY REPRESENTATION OR WARRANTY OF THE CONTRACTOR CONTAINED IN THE CONTRACT DOCUMENTS, PROVIDE THAT ANY SUCH CLAIM, COST, LOSS OR DAMAGE:

1. IS ATTRIBUTABLE TO BODILY INJURY, SICKNESS, DISEASE OR DEATH, OR TO INJURY TO OR DESTRUCTION OF TANGIBLE PROPERTY (OTHER THAN THE WORK ITSELF), INCLUDING THE LOSS OF USE RESULTING THEREFROM; AND

2. IS CAUSED IN WHOLE OR IN PART BY ANY NEGLIGENT ACT OR OMISSION OF CONTRACTOR, ANY SUBCONTRACTOR, ANY SUPPLIER, OR ANY INDIVIDUAL OR ENTITY DIRECTLY OR INDIRECTLY EMPLOYED BY ANY OF THEM TO PERFORM ANY OF THE WORK OR ANYONE FOR WHOSE ACTS ANY OF THEM MAY BE LIABLE, REGARDLESS OF WHETHER OR NOT CAUSED IN PART BY ANY NEGLIGENCE OR OMISSION OF AN INDIVIDUAL OR ENTITY INDEMNIFIED HEREUNDER OR WHETHER LIABILITY IS IMPOSED UPON SUCH INDEMNIFIED PARTY BY LAWS AND REGULATIONS REGARDLESS OF THE NEGLIGENCE OF ANY SUCH INDIVIDUAL OR ENTITY.

IT IS THE EXPRESSED INTENTION AND AGREEMENT OF THE PARTIES HERETO THAT THE INDEMNITY PROVIDED HEREIN IS AN AGREEMENT BY CONTRACTOR TO INDEMNIFY AND PROTECT THE INDEMNITEES HEREIN FROM SUCH INDEMNITEES' OWN ACTUAL OR ALLEGED NEGLIGENCE OR OMISSIONS, WHERE SAID NEGLIGENCE OR OMISSION IS AN ALLEGED OR ACTUAL CONCURRING OR JOINT PROXIMATE CAUSE OF ANY HARM TO ANY CLAIMANT, WHETHER IN THE NATURE OF PERSONAL INJURY, PROPERTY DAMAGE, LOSS OF USE, OR OTHERWISE.

OWNER AND CONTRACTOR ACKNOWLEDGE THAT THIS STATEMENT AND FOREGOING INDEMNIFICATION COMPLIES WITH THE EXPRESS NEGLIGENCE RULE AND IS CONSPICUOUS AND HAS BEEN REVIEWED AND APPROVED BY EACH PARTIES OWN RESPECTIVE INDEPENDENT LEGAL COUNSEL. THE INDEMNIFICATION ARISING HEREIN SHALL SURVIVE THE TERMINATION OF THIS AGREEMENT.

Article 8 - MISCELLANEOUS

- **8.1** No assignment by a party hereto of any rights under or interests in the Contract Documents will be binding on another party hereto without the written consent of the party sought to be bound; and specifically, but without limitation, moneys that may become due and moneys that are due may not be assigned without such consent (except to the extent that the effect of this restriction may be limited by law), and unless specifically stated to the contrary in any written consent to an assignment no assignment will release or discharge the assignor from any duty or responsibility under the Contract Documents.
- **8.2 OWNER and CONTRACTOR** each binds itself, its partners, successors, assigns and legal representatives to the other party hereto, its partners, successors, assigns and legal representatives in respect of all covenants, agreements and obligations contained in the Contract Documents.







- 4. <u>Materials</u>: The Port will not supply any materials.
- 5. <u>Project Site:</u> It is the responsibility of each bidder to inform himself fully of the conditions relating to the construction and labor under which the work will be performed, and will have inspected the site. Contact David M. Knuckey, P.E. to arrange a site visit. The project site is located within a Marine Transportation Securities Act regulated area. All personnel will need to have either a valid Transportation Workers Identification Credentials (TWIC card) or be escorted by a person holding a valid TWIC card. It is recommended that at least two on-site employees hold valid TWIC cards.
- 6. Insurance: Prior to the Port issuance of a Purchase Order, the successful low bidder will be required to provide the Port with Certificates of Insurance in at least the following amounts;

General Public Liability	\$1,000,000 per person / per incident \$2,000,000 general aggregate
Marine Liability	\$1,000,000 per person / per incident \$2,000,000 general aggregate
Automotive Public Liability	\$2,000,000 (any auto) each accident
Workmen's Compensation	\$1,000,000 each accident \$1,000,000 policy limit \$1,000,000 each person
Pollution Liability Insurance	\$1,000,000 per occurrence

- 8. <u>Working Hours</u>: In general, working hours are from 7:00 a.m. to 5:00 p.m., Monday through Friday unless prior arrangements are made with the Port. This area is an active loading/unloading area of liquid chemicals. Close coordination with the Port Operations Department will be required to complete the project.
- 9. <u>Project Schedule</u>: Award of Contract will be the issuance of a purchase order by the Port. Award of Contract will be based on two factors: (1) the lowest qualified bid received, and (2) the experience level of the company and individuals assigned to the Project that is in the best interest of the Port as determined by the Port. It is anticipated that a purchase order will be issued within thirty (30) calendar days of the above referenced deadline for submittal of proposals. It is anticipated that all work should be completed within **Thirty (30) calendar days** of issuance of a purchase order by the Port.

- 9. <u>Payment</u>: Upon completion of all work and acceptance by the Port, payment will be made in full within **thirty (30)** calendar days.
- 10. <u>Sales Tax</u>: The Port is exempt from state sales tax. The Port will issue a Certificate of Exemption from Texas State Sales Tax to the successful bidder.
