Agenda Item No. 6: Port Director's Report.

Charles R. Hausmann, Port Director, reported the following:

A. Harbor Traffic Statistics for the month of November:

That a total of 130 vessels had arrived at the public port facilities during the month of November; 28 deep draft arrivals and 102 inland barges and a total of 253 invoices were issued. Further, that 18 deep draft vessels were already on schedule for December arrival.

Total revenue tons for the month of November were 495,742.1 short tons. Total revenue tons for the first five months of FY 2019 were 2,312,429.8.

- B. NGL loaded out 18 crude oil barges totaling 60,532.4 short tons.
- C. Seadrift Coke lightered 3 barges of needle coke totaling 4,959.2 short tons to 1 ship for export.
- D. Harvest loaded out 6 crude oil barges totaling 20,874.7 short tons.

The Board Members reviewed a copy of the proposed easement agreement between the Calhoun Port Authority and Enterprise Intrastate, LLC. This was for a 6.5 rod, 8-inch pipeline that would service the Formosa EG-2 Project. The easement was located on property leased by Matagorda Bay Costa Azul Terminal LLC and the charge was \$10,000.00 for a ten-year period plus an administrative fee of \$2,500.00 for document preparation. Pursuant to further review and discussion, a motion was made by Board member Dell R. Weathersby to approve the easement between the Calhoun Port Authority and Enterprise Intrastate, LLC. For a 6.5 Rod, 8-inch pipeline with the conditions as discussed. The motion was seconded by Board Member Tony Holladay and the motion carried unanimously.
